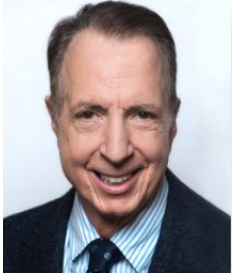
Daniel Teo, Hunniwell Lake Ventures, Managing Partner
